

ANNUAL FLU VACCINE REMINDER Deadline: 12/31/24

As a reminder, the State of New Jersey requires <u>ALL</u> employees of certain healthcare facilities, including nursing homes, to receive an annual influenza vaccine, including employees who are not responsible for direct patient care.

The only exception to the vaccination requirement is for those individuals who have a valid medical reason. Those who seek the medical exemption must complete an attestation form to be submitted to the New Jersey Department of Health. For any employees previously approved for a medical exemption, please be advised that the *Medical Exemption*Statement for Health Care Personnel will once again be required to be completed in full for the 2024/2025 flu season, by December 31, 2024, as that is an annual requirement.

Anyone approved for a medical exemption will be required to wear a mask <u>at all times</u> during flu season, October 1st through April 1st.

The statute does not allow for a religious exemption.

Note: If you received your 2024 flu shot at a pharmacy or physician's office, please provide a copy to Gina Martinez, Employee Health Nurse, as soon as possible.
